I understand if I violate this pledge (determined by peers, advisors, and UNITY), UNITY reserves the right to prohibit my participation at any time during the conference and will ask me (participant) to return home immediately at my (participant's or parent's/guardian's) expense.

I acknowledge that I am at least 18 years of age OR an authorized parent/guardian/advisor/chaperone of the person named in this registration.

I will not hold liable United National Indian Tribal Youth, Inc., nor any of its agents, volunteers, or other organizations involved in this UNITY event, including, but not limited to Washington Portland Convention Center in Portland, OR, and 3rd Party Vendors contracted by UNITY for the 2024 National UNITY Conference.

UNITY HONOR CODE

National UNITY Council (NUC) Constitution and Bylaws

1 a. The Code of Honor Committee recommends the following as the National UNITY Council's Code of Honor Contract to be signed by each National UNITY Council representative at the beginning of his or her respective term:

As a youth council representative serving on the National UNITY Council, I agree to uphold the standards set forth within the following Code of Honor:

- Maintain and promote a healthy mind, body, and lifestyle.
- Observe high standards of taste and decency (in person and online). This includes refraining from cyberbullying, disorderly, lewd, indecent, or obscene conduct or expression.

- Refrain from drug and alcohol abuse. This includes refraining from the possession, use or distribution of any illicit drug (as defined by applicable law) and the abuse of alcohol.
- Be honest.
- Respect all personal rights. This includes not physically or verbally abusing any person
 and not engaging in conduct that threatens or endangers the health or safety of others and
 their property—not obstructing or disrupting others in the performance of official duties
 by officers, functions or other authorized activities of the National UNITY Council.
 Refraining from theft, concealment of weapons, damage or misuse of the property of
 others.
- Honor the law of the land.
- Help other National Council Representatives fulfill their responsibilities under this code.

1 b. Compliance

I will conduct myself positively and the best interest of UNITY at all times. Failure to comply in accordance with the Roles and Responsibilities of National UNITY Council Representatives shall result in disciplinary action(s) as warranted by the Peer Mediation Committee.

MEDICAL AUTHORIZATION AND LIABILITY RELEASE

In the event of illness or accident during my participation at the 2024 National UNITY Conference, I give UNITY my consent to receive medical attention.

PHOTOGRAPHIC RELEASE

I acknowledge that I may be photographed or videotaped during my participation at the 2024 National UNITY Conference and give permission for my likeness (image, voice) to be used in the UNITY program, promotional, and reporting materials.

PAYMENTS AND REFUND POLICY

PAYMENT BY CHECK: All registrations must be paid **before the next rate increase.** If you register on the last day of the advertised rate, you must pay the same day (postmarked). Your registration rate will increase if payment is not received by the announced deadline for each rate. **Payment by checks must be made by June 2, 2023, or registration(s) will be canceled.**

PAYMENT WITH A PURCHASE ORDER (PO): Payment with a purchase order will be charged a non-refundable \$25 processing and administrative fee to complete registration(s). **Purchase order payments must be made by June 2, 2023, or registration(s) will be canceled.**

REFUND POLICY: **A No Refund Policy will be effective starting July 1, 2023.** There is a \$25.00 processing and administrative fee (for each registration) for all requested refunds before July 1, 2023. All cancellations after June 30, 2023, will not be refunded or reimbursed.
