As a participant (youth, adult, exhibitor, vendor, etc.), I pledge to conduct myself in a manner that will bring honor to myself, my tribe and community. I understand if I violate this pledge (determined by peers, advisors and UNITY), UNITY reserves the right to prohibit my participation at any time during the National UNITY Conference and will ask me (participant) to return home immediately at my (participant's or parent's/guardian's) expense.

I will not hold liable United National Indian Tribal Youth, Inc., nor any of its agents, volunteers, or other organizations involved in this UNITY event, including, but not limited to 3rd Party Vendors contracted by UNITY for the purposes of the National UNITY Conference.

In the event of illness or accident during my participation I give UNITY my consent to receive medical attention.

I acknowledge that I may be photographed or videotaped during my participation at the 2024 UNITY Conference and give permission for my likeness (image, voice) to be used in UNITY program, promotional and reporting materials now and in the future.

Waiver of Liability Related to COVID-19, COVID-19 Variants, or another Communicable Disease

The Coronavirus, COVID-19 and COVID-19 variants have been declared a worldwide pandemic by the World Health Organization. COVID-19 and COVID-19 variants are reported to be extremely contagious with the capacity to transmit from person-to-person through respiratory droplets and/or by contact with contaminated surfaces and objects. The government has set recommended guidelines for limiting the transmission of COVID-19 and COVID-19 variants, and UNITY, Inc. will implement and strictly enforce these guidelines among the attendees, and staff during the 2024 National UNITY Conference

Even with these measures, it is not possible to completely prevent the presence of the disease. UNITY, Inc., the Washington Hilton, and contracted event organizers cannot guarantee that you will not become exposed to or contract COVID-19 and COVID-19 variants, or another communicable disease that may be incurred in connection with my and/or my child(ren)'s

- You have not been diagnosed with COVID-19 or COVID-19 variant and not yet cleared as non-contagious by state or local public health authorities within 14 Days prior to the event date.
- You are following all CDC recommended guidelines and limiting your exposure to COVID-19 or COVID-19 variant or another communicable disease.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19 and COVID-19 variants, or another communicable disease, and am electing to attend the UNITY Conference in-person or am authorizing my minor child(ren) to attend in person. By signing this document, I acknowledge the contagious nature of COVID-19 and COVID-19 variants and knowingly and voluntarily assume the risk that I or my child(ren) may be exposed to or infected by COVID-19 and COVID-19 variants by attending the 2023 National UNITY Conference and that such exposure or infection may result in personal injury, illness, permanent disability, and death. UNITY HONOR CODE

National UNITY Council (NUC) Constitution and Bylaws Honor Code

1 a. The Code of Honor Committee recommends the following as the National UNITY Council's Code of Honor Contract to be signed by each National UNITY Council representative at the beginning of his or her respective term:

As a youth council representative serving on the National UNITY Council, I agree to uphold the standards set forth within the following Code of Honor:

- Maintain and promote a healthy mind, body, and lifestyle.
- Observe high standards of taste and decency. This includes refraining from disorderly, lewd, indecent or obscene conduct or expression. (in person or online in digital form)
- Refrain from drug and alcohol abuse. This includes refraining from the possession, use or distribution of any illicit drug (as defined by applicable law) and the abuse of alcohol.
- Be honest.
- Respect all personal rights. This includes not physically or verbally abusing any person and not engaging in conduct that threatens or endangers the health or safety of others and their property. Not obstructing or disrupting others in the performance of official duties by officers, functions or other authorized activities of the National UNITY Council. Refraining from theft, concealment of weapons, damage or misuse of the property of others.
- Honor the law of the land.
- Help other National Council Representatives fulfill their responsibilities under this code.
